B. State of Good Repair Application [APPROVE]

Summary: FCRTA has submitted a project for FY 21-22 through the CalSMART portal for \$335,199 in State Transit Assistance funding from the Senate Bill 1 State of Good Repair Account (SGR). These funds will be utilized to construct a new Bus Maintenance and Fuel Yard Facility.

Action: Staff recommends adoption of Board Resolution No 2021-18.

C. Request for Qualification (RFQ) Fleet Maintenance Facility Project [INFORMATION]

Summary: FCRTA released a Request for Qualification (RFQ) on June 30th for the design and construction of the Fleet Maintenance Facility in Selma. FCRTA solicited Statements of Qualifications (SOQs) from DB Entities in order to solicit information in the form of a qualification questionnaire and qualification statements to create a short-list of up to the three of the most highly qualified Entities and the short-listed Entities will be issued a Request for Proposals (RFP). FCRTA received five (5) SOQs from DB Entities from Zumwalt, Diede, Harris, Wu & Associates and AMG. The scoring panel reviewed the proposals on August 16th and Harris and Zumwalt were selected for the short-list and will be issued the RFP. Following receipt of Proposals, FCRTA will select the proposal that FCRTA determines to provide the best value, based on qualifications and other factors that will be set forth in the RFP. It is FCRTA's intent to award a single contract to a selected DB Entity to deliver this project.

Action: Information only. The Board may provide additional direction at its discretion.

D. Grant Agreement Conflict Waiver for Representation of the FCRTA and FCTA [APPROVE]

Summary: FCRTA was awarded a grant through the Measure C New Technology Reserve Grant Program. The project includes the purchase of four (4) 23-foot C6 BYD electric buses and fifty (50) UV Germicidal Disinfectant Lights to for the existing rural transit services as well as a new shuttle service. As part of the grant procedures, FCRTA will enter into an agreement with the Fresno County Transportation Authority (FCTA) as the administer of the grant funding. The Office of Fresno County Counsel provides legal services to FCRTA, and also has been asked to represent FCTA with regard to the drafting and review of the agreement. One of the office's deputy county counsels already provides legal representation to the FCRTA in all matters, pursuant to a legal services agreement between the FCRTA and the County of Fresno, and would provide representation in this agreement negotiation as well. Another deputy county counsel provides legal services to FCTA, and will assist FCTA in the drafting and review of the agreement. The Office of Fresno County Counsel will provide "dual representation" in this particular instance, and attached is the Conflict Waiver for your review (ATTACHMENT).

<u>Action:</u> Staff recommends Board Approval of the Conflict Waiver for representation of the FCRTA and FCTA regarding conflict for administration of grant funding.

E. <u>National Rural Transportation Assistance Program (RTAP) Community Rides Grant Award</u> [APPROVE]

Summary: National Rural Transit Assistance Program (RTAP) Community Rides Grant Program offers current recipients and subrecipients of the Federal Transit Administration (FTA)'s Formula Grants for Rural Areas (Section 5311) program the opportunity to apply for grant awards of up to \$100,000 for projects that develop or strengthen transportation partnerships that improve social determinants of health in rural and tribal communities.

FCRTA submitted a grant application in the amount of \$100,000 to the National Rural Transportation Assistance Program (RTAP) Community Rides Grant. On September 1, 2021 FCRTA was notified that the application was awarded for the amount of \$59,500. This project is a planning study to analyze the communities of Riverdale, Laton, Lanare, Cantua Creek, and El Porvenir for possible expansion of the existing on-demand electric rideshare/micro transit services. Leadership Counsel is a project partner, providing the community outreach and engagement component. Also, Walker Consulting on retainer for FCRTA will be providing the project oversight.

Conflict Waiver:

Representation of the FCRTA and FCTA regarding contract for administration of funding grant

It has been proposed that the Fresno County Rural Transit Agency (FCRTA) enter into a contract with the Fresno County Transportation Authority (FCTA) to administer a grant of funding.

As you know, the Office of Fresno County Counsel provides legal services to FCRTA, and also has been asked to represent FCTA with regard to the drafting and review of said contract. One of our office's deputy county counsels already provides legal representation to the FCRTA in all matters, pursuant to a legal services contract between the FCRTA and the County of Fresno, and would represent it in this contract negotiation as well. Another deputy county counsel provides legal services to FCTA, and will assist FCTA in the drafting and review of the contract. Accordingly, we are required to inform you regarding the proposal that our Office provide such "dual representation" in this particular instance, and to obtain your informed written consent.

RULES OF PROFESSIONAL CONDUCT

Rule 1.7 of the California Rules of Professional Conduct provides, in pertinent part:

- (a) A lawyer shall not, without informed written consent from each client and compliance with paragraph (d), represent a client if the representation is directly adverse to another client in the same or a separate matter.
- (b) A lawyer shall not, without informed written consent from each affected client and compliance with paragraph (d), represent a client if there is a significant risk the lawyer's representation of the client will be materially limited by the lawyer's responsibilities to or relationships with another client, a former client or a third person, or by the lawyer's own interests.
- (c) Even when a significant risk requiring a lawyer to comply with paragraph (b) is not present, a lawyer shall not represent a client without written disclosure of the relationship to the client and compliance with paragraph (d) where:
 - the lawyer has, or knows that another lawyer in the lawyer's firm has, a legal, business, financial, professional, or personal relationship with or responsibility to a party or witness in the same matter; or
 - (2) the lawyer knows or reasonably should know that another party's lawyer is a spouse, parent, child, or sibling of the lawyer, lives with the lawyer, is a client of the lawyer or another lawyer in the lawyer's firm,* or has an intimate personal relationship with the lawyer.
- (d) Representation is permitted under this rule only if the lawyer complies with paragraphs (a), (b), and (c), and:
 - the lawyer reasonably believes that the lawyer will be able to provide competent and diligent representation to each affected client;

- (2) the representation is not prohibited by law; and
- (3) the representation does not involve the assertion of a claim by one client against another client represented by the lawyer in the same litigation or other proceeding before a tribunal.

CONSEQUENCES OF THE REPRESENTATION

We are obliged, under the rule cited above, to inform you of any actual or reasonably foreseeable adverse effects of this representation. It is possible that conflicts between the FCTA and FCRTA may develop into disputes. This scenario could have potentially problematic results in regard to our representation of the FCRTA, specific examples of which are:

- Someone may argue that we would be tempted to favor the interests of one client over the other.
- Our exercise of independent judgment to the FCRTA may be impaired or clouded by our pre-existing relationship with FCTA.
- We may not be able to present the appropriate position, claims or defenses for one client in order to avoid taking adverse positions to the other client.
- We may be restricted from forcefully advocating a client's position for fear of alienating the other client.
- We may be forced to withdraw from representing either or both clients because of disputes or further conflicts of interest which could increase either or both clients' attorney's fees and costs.
- There may be an appearance of impropriety in our representation of both clients simultaneously.

Our office believes that we can adequately mitigate any risks of these consequences, especially since this is for such a discrete task. 1) We will have two different attorneys in our office represent each side of the contract; 2) neither attorney will have access to the other's files or documents as regards this contract; and 3) the two attorneys will not discuss the matter with each other, except in arm's-length negotiations on behalf of their respective clients when authorized by the clients to do so, and 4) each attorney will report to different superiors with any issues that arise. Moreover, this is simply a contract for the administration of grant funding and the parties have a preexisting governmental relationship. Under these circumstances, the parties do not appear to be adverse with respect to this transaction. As regards reviewing the subject contract, the attorney representing FCRTA will report to Chief Deputy Brian Melikian, and the attorney representing the FCTA will report to County Counsel Dan Cederborg.

YOUR CONSENT

If you wish to have our office to represent the FCRTA in this matter, we will need to have the FCRTA Board authorize its Chairman to sign this consent letter. It is understood that this consent will not prevent County Counsel from representing the FCRTA now or in the future, and

will not waive any protection that you may have with regard to attorney-client communications with us in this matter. Those communications will remain confidential and will not be disclosed to any third party without your consent. The files will be kept separate and there will be no communication regarding the respective representations except as among those persons solely working for that entity.

If there is any material change in the circumstances described above, or we become aware of new information that requires a new consent from the parties, you will be notified of that fact immediately, and in such event our continued representation will be subject to the informed written consent of both involved parties in connection therewith.

Your execution of this consent letter will constitute an acknowledgment of full disclosure in compliance with the requirements of Section 1.7 of the California Rules of Professional Conduct previously quoted above.
