B. MOU Biola Community Services District [APPROVE]

Summary: FCRTA deployed a microtransit program on October 3rd on a demonstration basis in the community of Biola. The microtransit service utilizes Chevy Bolt electric vehicles and is operated by FCRTA's subcontractor MV Transportation. MV has hired a local driver in the community of Biola for the service. The League of Women Voters has generously donated \$12,000 to be used as a 50% subsidy for fares for passengers which is providing an excellent opportunity to make this pilot project successful by providing a discounted fare for these passengers. FCRTA will be installing a Level 2 charging unit and automated gate at the Biola Community Services District (BCSD) parking lot where the electric vehicle will be stored to provide charging and increased security. The MOU with the BCSD is available at the FCRTA website www.ruraltransit.org.

Action: Staff recommends Board approval of the MOU with the Biola Community Services District.

C. AB 361- Board Meeting Format [ACTION]

<u>Summary</u>: On Sept. 15, 2021, Governor Newsom signed Assembly Bill (AB) 361, amending the Ralph M. Brown Act to allow local agency councils, boards and committees to continue conducting public meetings remotely during a state of emergency after Oct. 1, 2021, so long as they make specific findings every 30 days, and ensure conditions related to public participation are satisfied. Under the Brown Act, the Policy Board, FCRTA Board, TTC and PAC and other Fresno COG committees are considered "legislative bodies," according to the Fresno County Counsel's office. Under the urgency legislation, a local agency may use the more "relaxed" Brown Act teleconferencing/videoconferencing requirements in any of the following circumstances:

- There is a proclaimed state of emergency, and state or local officials have imposed or recommended measures to promote social distancing; or
- There is a proclaimed state of emergency, and the local agency's meeting is to determine, by majority vote, whether as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees; or
- There is a proclaimed state of emergency, and the local agency has determined, by majority vote, that as a result of the emergency meeting in person would present an imminent risk to the health or safety of attendees.

AB 361 defines a "state of emergency" as a state of emergency proclaimed pursuant to Section 8625 of the California Emergency Services Act. Importantly, this includes the Governor's proclaimed state of emergency due to the COVID-19 pandemic. To continue to rely on the relaxed video/teleconferencing provisions, the local agency must reconsider the circumstances of the state of emergency and make the following findings by majority vote, *every 30 days*:

- The state of emergency continues to directly impact the ability of members to meet safely in person; or
- A JOINT POWERS AGENCY TO PROVIDE A COORDINATED TRANSIT SYSTEM FOR RURAL FRESNO COUNTY The Cities of: Coalinga, Firebaugh, Fowler, Huron, Kerman, Kingsburg, Mendota, Orange Cove, Parlier, Reedley, Sanger, San Joaquin, Selma & Fresno County

State or local officials continue to impose or recommend measures to promote social distancing.

The recommended finding under this option would be that "The Board, meeting during a proclaimed state of emergency, has determined by majority vote, pursuant to AB 361 subparagraph (B), that, as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees."

While the Board has the option of using teleconferencing, as was available prior to COVID restrictions, the Brown Act requires: 1) a quorum of the legislative body to participate from within the boundaries of the agency's jurisdiction, 2) the public agency to post notice of each teleconference location, and 3) the public be allowed to address the legislative body from each teleconference location. These requirements place a significant burden on both Board members and staff.

Note that because of FCRTA's holiday schedule, the Board will need to hold short meetings at 5:30 p.m. following the Fresno COG meetings on **Dec. 15** and **Jan. 12, 2023** to issue AB 361 findings for the regular January 2023 meeting. Also, on Oct. 17, Gov. Newsom announced that he would be ending the COVID state of emergency on Feb. 28, 2023, which will necessitate at least a quorum of Board members present to conduct business beginning with the March 23, 2023 meeting.

Action: Staff recommends two actions:

1) That the Board issue the following findings: (a) The Board has reconsidered the circumstances of the state of emergency; and (b) As a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.

2) Reaffirm Resolution 2022-01 from Jan. 6, authorize the Board and subordinate legislative bodies to conduct their meetings in accordance with remote participation by teleconference in the manner provided by Government Code section 54953, subd. (e) through Dec. 15, and direct staff to continue providing video/teleconferencing provisions for all FCRTA Board meetings through Dec. 15.

A. Amendment I to the Design Build Agreement with Zumwalt Construction [APPROVE]

Summary: On February 24, 2022 the Board approved the award of the Selma Maintenance Facility Construction project to Zumwalt Construction Inc. following the Request for Qualification (RFQ) and Request for Proposal (RFP) process. FCRTA has completed work with the Zumwalt design-build team on the preconstruction phase including site evaluation and site designs. The construction phase will begin in November, commencement of work will begin in December, with an estimated completion date of October 2023. Zumwalt has received final estimates for Phase 1 and due to inflation and an increase in costs, the project total for Phase 1 is now \$14,853,340. This project is being funded by an FTA 5339 grant (\$5,145,281) and the remaining balance will be with State of Good Repair and local Measure C funding (\$9,708,059). The Amendment I is available at the FCRTA website www.ruraltransit.org. The letter to proceed is attached for your review (ATTACHMENT).

<u>Action:</u> Staff recommends Board approval of the Letter to Proceed with Construction and authorize General Manager to execute Amendment I to the Design Build Agreement with Zumwalt Construction in the amount not to exceed \$14,853,340.
