1. ROLL CALL

2. ACTION ITEMS

A. Rejection of Claim [APPROVE]

Summary: On June 10, 2023 FCRTA received a claim submitted on behalf of Maria Pinonez by the B&D Law Group of Los Angeles, CA. The claim relates an incident which allegedly occurred on January 21, 2023 on a bus in the City of Fresno, at bus stop 25/E. Olive & N. Attached is the Claim for Damages form and proposed Rejection Letter for your review (ATTACHMENTS).

The facts alleged in the claim demonstrate that the injury could not have occurred on equipment owned by FCRTA or as a result of the acts of any FCRTA agent or employee. Attempts to persuade the claimant's attorneys to withdraw the claim as to FCRTA have not succeeded.

Action: Staff recommends rejection of the claim and adoption of Resolution No. 2023-11.

B. FCRTA 2023-2024 Annual Budget [APPROVE]

Summary: The Budget has been prepared to reflect the Fresno Council of Governments (FCOG) 2022 Regional Transportation Plan (RTP) and the proposed Short Range Transit Plan for the Rural Fresno County Area for 2024-2028. The Budget and narrative recommends the implementation of programmed service improvements and continuation of existing services. The budget, which may require periodic amendments during the 2023-2024 fiscal year, is available on FCRTA's website ruraltransit.org.

Action: Open the public hearing, receive comments, and close the public hearing. Staff recommends Board approval of the FY 2023-24 Budget and adoption of Resolution No.2023-07.

B. Consolidated Transportation Services Agency (CTSA) Operations Program & Budget FY 2023-24 [APPROVE]

Summary: The Consolidated Transportation Service Agency's (CTSA) Operations Program and Budget (OPB) for 2023-24 is available on FCRTA's website at: www.ruraltransit.org. The document is designed to provide an overview of how and in what manner the CTSA will provide social service transportation throughout Fresno County over the next fiscal year. The OPB consists of an urban component and a rural component. Sole-designee for the urban CTSA is the City of Fresno/FAX and the sole-designees for the rural CTSA is the Fresno County Rural Transit Agency (FCRTA). For FY 2023-24 the rural LTF pass through totals \$200,000 for FCRTA to provide social service transportation including meal delivery as needed in the rural areas.

Action: Staff recommends Board approval of the Consolidated Transportation Services Agency (CTSA) Operations Program & Budget FY 2023-24.

C. Fresno Economic Opportunities Commission Contractor Services Agreement [APPROVE]

Summary: In 2020, the FCOG re-designated the CTSA's in the following: FCRTA is now the sole designee for Rural Fresno County and administers the funding, activities, and transportation programs of all CTSA service providers in Rural Fresno County and the City of Fresno (FAX) is the sole designee for the Fresno Metropolitan Area and administers the funding, activities, and transportation programs of all CTSA service providers within the Fresno Metropolitan Area. Through a RFP process, Fresno Economic Opportunities Commission (FEOC) was selected as the primary provider of CTSA services. The Contractor Services Agreement with FEOC to provide the CTSA services is available at the FCRTA website www.ruraltransit.org.

Action: Staff recommends Board approval of the FEOC Contractor Services Agreement.

D. 2024-2028 Short Range Transit Plan for the Rural Fresno County Area [APPROVE]

Summary: The Short Range Transit Plan (SRTP) for the rural Fresno County area has been developed by the Fresno Council of Governments (Fresno COG), and updated by FCRTA in cooperation with the Cities of Coalinga, Firebaugh, Fowler, Huron, Kerman, Kingsburg, Mendota, Orange Cove, Parlier, Reedley, Sanger, San Joaquin, Selma and County of Fresno. The SRTP for the rural Fresno County area provides a five (5) year action-oriented program to implement the Public Transportation Element of the Regional transportation Plan (2022). The document is available for your review on the FCRTA website www.ruraltransit.org.

Action: Staff recommends Board approval of the Short Range Transit Plan for the Rural Fresno County 2024-2028 and adoption of Resolution No. 2023-05.

E. Safety and Security Service Agreements for FY 2023-24 [APPROVE]

A JOINT POWERS AGENCY TO PROVIDE A COORDINATED TRANSIT SYSTEM FOR RURAL FRESNO COUNTY

The Cities of: Coalinga, Firebaugh, Fowler, Huron, Kerman, Kingsburg, Mendota, Orange Cove, Parlier, Reedley, Sanger, San Joaquin, Selma & Fresno County

Summary: FCRTA is continuing the Safety and Security service for passengers and drivers with this collaborative partnership that has proven beneficial and continues to be very successful for the Police Departments of all 13 member agencies and FCRTA. Our passenger incidents and 911 calls have decreased over the five (5) years since this program has been in place. Each contract has a maximum of \$10,000.00 annual payment for costs associated with providing this service of boarding buses when they are at transit stops and monitoring bus shelters. The agreement is available at the FCRTA website www.ruraltransit.org.

Action: Staff recommends Board approval and authorize General Manager to execute agreements for each City in the amount not to exceed \$10,000.00 for FY 2023-2024.

F. Amendment III to the Walker Contractor Services Agreement [APPROVE]

Summary: The Board approved in June 2022, the extension to the Contractor Services Agreement with Walker Consultants in the amount not to exceed \$60,000. It is necessary and desirable that FCRTA extend this agreement until June 30, 2024 to continue to provide technical assistance with specific transit related EV, mobility and capital grant projects. FCRTA anticipates pursuing additional local, state and federal funding opportunities and will require the additional technical assistance. The Amendment III to the Walker Consultants Contractor Services Agreement is available at the FCRTA website www.ruraltransit.org.

Action: Staff recommends Board approval of Amendment III to the Walker Consultants Contractor Services Agreement in the amount not to exceed \$60,000.

G. Kings Area Rural Transit Agreement for FY 2023-24 [APPROVE]

Summary: This is a regional public transit service agreement renewal with the Kings Area Rural Transit for services from Kings County in Fresno County; Selma Kaiser, Valley Children's Clinic in Fowler, Downtown Fresno, Community Regional Center, Veterans Hospital, Fresno Kaiser and Children's Hospital. This agreement is for \$60,000 and is effective 7/01/23 to 6/30/24. The KART agreement is available at the FCRTA website www.ruraltransit.org for your review.

Action: Staff recommends Board approval and authorize General Manager to execute agreement with KART in the amount not to exceed \$60,000.

H. Amendment VII to the Agreement for Contractor Services with MV Transportation [APPROVE]

Summary: The Board approved in September 2020 Amendment IV to the Agreement for Contractor Services with MV. This Amendment IV continued contracted services with MV Transportation for an additional 4 years (2021-2025) which was an option in the 2018 Request for Proposal (RFP). This Amendment required approval from Caltrans staff as they approved the original 2018 RFP and Contractor Services Agreement. Staff is recommending extending the contractor services agreement for the 3rd year of the 4 option years. Caltrans has reviewed and approved Amendment VI on May 11, 2023. The approval letter from Caltrans and the Amendment VII to the Agreement for Contractor Services with MV Transportation is available at the FCRTA website www.ruraltransit.org.

Action: Staff recommends Board approval of the Amendment VII and authorize General Manager to execute Amendment VII to the Agreement for Contractor Services with MV Transportation.

I. Amendment IV to the Agreement for Maintenance Services with City of Selma [APPROVE]

Summary: As a result of the 2018 Request for Proposals (RFP), City of Selma was awarded a three (3) year agreement to provide maintenance services to the FCRTA vehicle fleet. Staff is recommending extending the maintenance services agreement. The option to renew the contract for an additional 4 years in one year increments was included as an option in the 2018 RFP. Amendment IV to the Agreement for Maintenance Services with City of Selma is available at www.ruraltransit.org.

Action: Staff recommends Board approval of the Amendment IV and authorize General Manager to execute Amendment IV to the Agreement for Maintenance Services with City of Selma.

J. Title VI of the Civil Rights Act of 1964 Program Updates (APPROVE)

Summary: The current FCRTA Title VI Program is required to be updated to continue to be eligible for State and Federal funding. This update will be submitted to Caltrans before it is sent to Federal Transit Administration (FTA). The document is available for your review on the FCRTA website www.ruraltransit.org.

Action: Staff recommends approval of the Title VI Program and further recommends Board approval of Resolution No.2023-10.

K. Caltrans ZEV Technical Assistance Agreement with Caltrans (APPROVE)

Summary: Caltrans has been working to provide Zero Emission Vehicle Technical Assistance to rural transit operators, and FCRTA was approached by Caltrans to partner with us on this effort. Caltrans has secured \$406,642 of FTA 5304 funding to provide a Zero Emission Vehicle Transition Plan Template and Technical Assistance to rural transit operators across California. FCRTA has already made great strides in this area and will build upon this work for this effort. FCRTA will work with a consultant to complete the ZEV Transition Plan Template and provide Technical Assistance to as many agencies as possible within the funding amount.

Action: Staff recommends Board approval of the agreement with Caltrans and adoption of Resolution No. 2023-12.

L. San Joaquin Valley Air Pollution Control District Clean Vehicle Fueling Infrastructure Grant Application (APPROVE)

Summary: FCRTA is proposing a project submittal to the San Joaquin Valley Air Pollution Control District's Clean Vehicle Fueling Infrastructure Grant Program. The project application is for Phase 2 of the Maintenance Facility Project which includes installation of a solar field, a third bus port, battery energy storage system, and ten (10) Level 2 EV charging stations. The total project cost is \$2,624,972 and FCRTA is requesting \$1,706,232 in grant funds and a match of \$918,740 in local Measure C funds.

Action: Staff recommends Board approval of the San Joaquin Valley Air Pollution Control District Clean Vehicle Fueling Infrastructure Grant Application and adoption of Resolution No.2023-13.

M. Federal Transit Administration (FTA) Section 5311 Application (APPROVE)

Summary: The 5311 application to Caltrans for operating assistance will be submitted via the electronic "Black Cat" system. This funding apportionment is used by FCRTA for the operation of all subcontracted transit services. The application is for \$2,253,819.

Action: Staff recommends Board approval of the 2022-23 FTA 5311 operating assistance application to Caltrans and adoption of Board Resolution No. 2023-09.

A motion was made by Mayor Robertson (Selma) and second by Mayor Pro Martinez (Mendota). A vote was called, and motion carried.

3. ACTION ITEMS

A. FCRTA Zero Emission Bus Rollout Plan

Janelle Del Campo informed the Board that FCRTA has completed our EV-Rollout Plan, and this will be submitted to CARB. This is a requirement by CARB and they are requiring all transit agencies to submit a complete zero emission bus rollout plan showing how transit agencies plan to achieve a transition to zero emission vehicles. This document lays out the planning that's essential for vehicle procurements, infrastructure buildout and costs for transitioning to an electric fleet. In order to transition to electric it is estimated that the cost will be approximately \$34 million to transition to a fully electric bus fleet, as well as estimated \$3 million in charging infrastructure, FCRTA will need to continue to apply for funding opportunities and contribute to local match requirements, capitalize on rebates programs, and continue to program a healthy capital budget to meet the 2030 fleet transition goals. There are a number of challenges we face with transitioning to electric and this includes battery range limits, high capital costs, unknown maintenance costs, the infrastructure needed for charging and grid restraints and these are all outlined in the rollout plan. This is a live document and updates will be made as needed.

Mayor Pacheco (Kerman) asked how the buses are retired and Moses Stites informed the Board they are retired and go through an auction process. Councilmember Fast asked if we will keep any gasoline vehicles and Moses informed the Board that FCRTA will keep some gasoline vehicles since transit provides lifeline services.

A motion was made by Mayor Robertson (Selma) and second by Mayor Pacheco (Kerman). A vote was called, and motion carried.

4. OTHER ITEMS

1. Moses informed the Board of a ribbon cutting taking place in the community of Biola on June 16, 2023. The event will be at the Biola Community Services District for our innovative Micro Transit Program. This program is the first of its kind for a rural transit operator. The service uses a Chevy Bolt electric vehicle and MV Transportation our subcontractor has hired a Biola resident as a trained and dedicated driver for the program, ensuring transportation for local residents to access life-saving medical appointments, social services, and other essential needs. The event marks a significant milestone, showcasing the successful partnership between various local and state agencies. This micro transit project is a collaborative effort between the Fresno County Rural Transit Agency, the Biola Community Services District, funding from Measure C, and a generous contribution from the League of Women Voters, who have provided funding toward the fares of Biola residents.

WHEREAS, the Short Range Transit Plan for the Rural Fresno County Area has also been prepared to comply with State requirements for Federal Transit Administration (FTA) Section 5311 requirements for Capital and Operating Assistance Grants, and
