B. Temporary Maintenance Facility Lease Agreement Extension [APPROVE]

<u>Summary:</u> The Board approved in June 2022, the lease agreement extension (8/15/2022-12/31/2023) for a temporary maintenance facility while the permanent maintenance facility is being built. The temporary site in Selma is located at 1870 Dockery Ave in the City of Selma across from the City yard and around the corner from the new maintenance facility site. FCRTA maintenance services will remain at this location and renew the lease up to an additional year while the new maintenance facility is being constructed. The monthly rent will be \$6,200 per month. The agreement extension is available on the website www.ruraltransit.org.

<u>Action:</u> Staff recommends Board approval of the agreement extension for the maintenance facility lease not to exceed one (1) year (12/31/2023-12/31/2024).

C. FCRTA Maintenance and Operations Facility Project Update [INFORMATION]

<u>Summary:</u> The FCRTA Maintenance and Operations facility project is currently under construction. The estimated completion date for the project is now August 2024, due to weather delays, long lead items, and the recent award of Phase 2 funding. Phase 1 is \$14,853,340 and is being funded by an FTA 5339 grant (\$5,145,281) and the remaining balance is with State of Good Repair and local Measure C funding (\$9,708,059). FCRTA was awarded for Phase 2 funding of the project by an FTA 5339 grant (\$2,162,886.74) with a local match of Measure C (\$540,721.68) for a total of \$2,703,608.42. Staff will return to the Board next month with the Amendment to the agreement with Zumwalt Construction for Design-Builder Services as well as an Amendment to the agreement with Kitchell for Construction Management Services.

D. Caltrans Planning Grant Application [INFORMATION]

<u>Summary:</u> FCRTA submitted an application for the Caltrans Sustainable Planning Grant to develop the Fresno County Transit Action Roadmap. This study would work with the community to identify existing service gaps through a comprehensive evaluation of FCRTA's operations in the 13 rural cities and 39 unincorporated areas of Fresno County. It would then evaluate strategies to reimagine existing services and potentially new options, such as partnerships to serve affordable housing sites and transit vouchers. It would also evaluate new technology for scheduling and ride requests as well as marketing, communication, and partnerships that have the potential to streamline service operations and promote ridership. The outcome would be an actionable roadmap for FCRTA to cost-effectively provide better service to ensure transit is a viable option for those that need it most, grow ridership, and leverage FCRTA's capital investments, such as the new maintenance facility and microgrids. FCRTA is requesting \$266,000 in grant funding and \$34,900 local match with Measure C funding for a total project cost of \$300,900.

E. <u>Transit Coordination Projects Update [INFORMATION]</u>

<u>Summary:</u> FCRTA is currently working on the following projects: 1) City of Mendota; As the City develops the old Airport for new commercial and recreation uses, FCRTA will partner with the City for transportation related support of these projects during the planning stages to secure funding to these proposed projects that will benefit the community and provide local and regional access to and from this location. Some of these partnerships include and are not limited to transportation, EV charging networks and alternative micro grid energy systems. These potential transportation improvements at the former Airport would also be applicable to the planned Community Center in Mendota. Also, the Fresno housing location in Mendota would be included in the Firebaugh effort to provide rides to these residents residing in there as reported last month. 2) City of Kerman; An effort led by the Mayor of Kerman to provide transportation to and from Kerman to Fresno City College was successfully launched on 1/08/24 with the collaboration of City College and FEOC. This effort was coordinated by utilizing the CTSA funding since this service is not considered general public transit, specifically City College is partnering in the match funding requirements and paying for monthly bus passes on behalf of the students during this demonstration period of 1 or more semesters depending on the ridership and continued funding. 3) MV Transportation; This agreement is coming due in FY 2024-25 after 7 years

which began in 2018. This is a requirement of FTA and Caltrans and will require oversight and approval by these two entities. We are currently in the 6th year and will need to begin work on this RFP process. Staff will keep the Board apprised of the status of this RFP process. Staff will continue to update the Board on these projects as they progress.

F. Fiscal Year Audit 2022-2023 [ACCEPT]

<u>Summary:</u> The CPA firm Price Paige and Co. have completed the 2022-23 Financial and Compliance audit for FCRTA. The report details that FCRTA managed its operations according to funding covenants and within budget. One finding was identified that was considered a material weakness however FCRTA still received a *clean opinion* because the finding has been corrected.

FCRTA's operating revenues were \$1,359,182 and operating expenses were \$10,094,272, which includes \$2,981,749 for depreciation. Non-operating revenues were \$5,753,341; however, when depreciation is netted out, revenues and expenses are in balance. Capital contributions net of depreciation were \$1,937,396, resulting in an ending net position of \$11,516,860. Copies of the audit and management letter will be available at the meeting to interested parties and available on FCRTA's website www.ruraltransit.org.

Action: Staff recommends Board acceptance of the 2022-23 FCRTA Financial and Compliance Audit.
