B. EV Charging Master Plan and Energy Management System Plan [INFORMATION]

<u>Summary:</u> FCRTA was awarded \$199,500 in funding through the Caltrans Sustainable Communities Transportation Planning Grant Program to conduct an electric vehicle charging master plan and energy management system plan. The project includes the development of a comprehensive EV charging master plan and an energy system management plan. Building on FCRTA's previous efforts, the EV

charging plan will evaluate the locations that charging equipment is needed, the types of equipment, cost of the equipment, electrical grid capacity, and integration with future microgrids. FCRTA has a need for an energy management system to monitor the energy needs, consumption, solar generation and storage. FCRTA released an RFP for Consultant services for this project on January 26th and proposals are due February 29th. FCRTA will return to the Board next month with a proposed recommended consultant.

C. RFP for Operations and Maintenance (INFORMATION)

<u>Summary:</u> At the end of last fiscal year, the Board approved services agreements with MV Transportation for operations and City of Selma for fleet maintenance. This agreement is coming due in FY 2024-25 after 7 years which began in 2018. This is a requirement of FTA and Caltrans and will require oversight and approval by these two entities. We are currently in the 6th year and will need to begin work on this RFP process. Staff will keep the Board apprised of the status of this RFP process and options.

D. Construction Management Services Agreement Extension [APPROVE]

<u>Summary:</u> The Board approved in October 2022, the agreement with Kitchell to provide construction management services as needed on an on-call basis up to 20 hours per week for the duration of the construction phase of the maintenance facility project for a total amount not to exceed \$194,150 based on a competitive bid process. An extension of the Construction Management Services Agreement is necessary due to the extended timeline of the maintenance facility project due to weather delays, long lead items, and the recently awarded FTA 5339 funding for Phase 2 of this project. The budget for the current agreement will be exhausted by April 30, 2024. Staff is recommending to extend the agreement to August 2024 for a total not to exceed budget of \$32,000 in order complete the project and provide assistance with close out. <u>Action:</u> Staff recommends Board approval of the agreement extension for construction management services in the amount not to exceed \$32,000 effective 5/1/2024 to 8/31/2024.

Councilmember Mary Fast (Reedley) pulled Item E. Moses informed the Board that FCRTA is working on projects in Mendota and Kerman. As the City develops the old Airport for new commercial and recreation uses, FCRTA will partner with the City of Mendota for transportation related support of these projects during the planning stages to secure funding to these proposed projects that will benefit the community and provide local and regional access to and from this location. Some of these partnerships include and are not limited to transportation, EV charging networks and alternative micro grid energy systems. The demonstration project in Kerman is currently underway for trips to Fresno City College. It launched on 1/08/24 with the collaboration of City College and FEOC. This effort was coordinated by utilizing the CTSA funding since this service is not considered general public transit, specifically City College is partnering in the match funding requirements and paying for monthly bus passes on behalf of the students during this demonstration period of 1 or more semesters depending on the ridership and continued funding

A motion was made by Mayor Martinez (Mendota) and second by Mayor Guerra Silva (Orange Cove). A vote was called, and motion carried.
