## B. <u>Consultant Selection for the EV Charging Master Plan and Energy Management System Plan</u> [APPROVE]

**<u>Summary</u>:** FCRTA was awarded \$199,500 in funding through the Caltrans Sustainable Communities Transportation Planning Grant Program to conduct an electric vehicle charging master plan and energy management system plan. The project includes the development of a comprehensive EV charging

Building on FCRTA's previous efforts, the EV charging plan will evaluate the locations that charging equipment is needed, the types of equipment, cost of the equipment, electrical grid capacity, and integration with future microgrids. FCRTA has a need for an energy management system to monitor the energy needs, consumption, solar generation and storage. FCRTA released an RFP for Consultant services for this project on January 26<sup>th</sup> and proposals were due February 29<sup>th</sup>. Staff received one proposal and on March 6<sup>th</sup>, 2024 a scoring committee representing FCRTA, Fresno COG and Clovis Transit interviewed the consultant and unanimously recommended Walker Consultants for this project. The proposed agreement is available on the FCRTA website <u>www.ruraltransit.org</u>

<u>Action:</u> Staff recommends Board approval of Walker Consultants as the consultant for the FCRTA EV Charging master Plan and Energy Management System Plan Project and authorize the General Manager to enter into an agreement with Walker in an amount not to exceed \$198,381.

## C. Biola Rural Microtransit Route Update (INFORMATION)

Summary: FCRTA deployed a microtransit program on October 3rd, 2023 on a demonstration basis in the community of Biola. The microtransit service utilizes Chevy Bolt electric vehicles and is operated by FCRTA's current subcontractor MV Transportation. MV has hired a local driver in the community of Biola for the service. The League of Women Voters has generously donated \$12,000 to be used as a 50% subsidy for fares for passengers. FCRTA has installed a Level 2 charging unit and automated gates at the Biola Community Services District (BCSD) parking lot where the electric vehicle is stored to provide charging and increased security. Ridership for this demonstration program has been extremely low to date and as a result, staff and the BCSD met and decided to make the following changes in order to make this route sustainable; update service hours from 24 hour advance reservation to same day reservation and fares have increased \$10 a trip to \$20 a trip. FCRTA will be able to gain a lot of information and data from this project, since it is the first microtransit service with very unique components; a local community resident hired as a driver, EV vehicle located at the site and infrastructure to support the EV. Staff will determine if it is cost effective and sustainable although we are serving residents in an unincorporated community and the rides are lifeline trips to doctor appointments, school, and shopping. Many passengers are disabled and elderly who have no other means of transportation. FCRTA will continue to monitor this route and determine if it is sustainable past a reasonable demonstration period.

# D. PG&E Fleet Ready Program Agreement [APPROVE]

**Summary:** FCRTA is currently constructing an operations and maintenance facility located in the City of Selma. As a public transit agency, FCRTA qualifies for the Fleet Ready Program and has been working with PG&E to participate in the program and receive power to the site. As part of the Fleet Ready Program, FCRTA is responsible for building and paying for the behind-the-meter portion of the project. PG&E has completed the preliminary design for the site and PG&E's design team estimates that this work will cost approximately \$896,413 based on negotiated contractor rates for utility-grade infrastructure. FCRTA is eligible for rebates towards EV vehicles and charges totaling \$660,000 through the Fleet Ready Program in order for PG&E to move the project into the design phase and begin engineering, design, and construction plans.
